Energy for Palmdale’s Independent Choice (EPIC) rates are established to cover operating expense of EPIC including power supply, administration, programs and reserves.

The rates shown in this document are for electric generation/supply only. Please visit SCE.com for delivery rates and schedules.

RATE PERIOD DEFINITIONS

SEASONS

Summer: season shall commence at 12:00 a.m. on June 1 and continue until 12:00 a.m. on October 1 of each year.

Winter: season shall commence at 12:00 a.m. on October 1 of each year and continue until 12:00 a.m. on June 1 of the following year

HOLIDAYS

Applicable holidays for rate time periods are as follows: New Year's Day (January 1), Presidents’ Day (third Monday in February), Memorial Day (last Monday in May), Independence Day (July 4), Labor Day (first Monday in September), Veterans Day (November 11), Thanksgiving Day (fourth Thursday in November), and Christmas Day (December 25).

When any holiday listed above falls on Sunday, the following Monday will be recognized as a holiday. No change will be made for holidays falling on Saturday.

RATE KEY

NET ENERGY METERING OPTION - NET SURPLUS COMPENSATION

Customers with behind-the-meter generation can elect the NEM option and receive a payment or credit for net surplus compensation (NSC) related to annual excess generation by their system.
